A PRISON IS . . .

a warehouse, at best, where human potential is left to stagnate. Upon release, an exoffender has little more than \$15, a prisonmade suit and a life experience that gives him little chance of making it in society.

For each convict who gets out of prison and makes it in the straight world, two others don't make it. Over and over men are stuck back in jail. Every time this happens another person is wasted; and each year we're taxed another \$12,000 per person for this waste to continue.

PACT COMMUNITY RESOURCE CENTER EXISTS TO . . .

DEFEAT THIS WASTE!

- EDUCATION: PACT helps to bring community education resources into the prison.
- COUNSELING: PACT appreciates the difficulties in the process of rebuilding a life and seeks to provide the kind of help that opens a man up to his own unique abilities and heals his damaged attitudes.
- EMPLOYMENT: PACT finds jobs for ex-offenders and helps to secure their economic stability in the community.
- SUPPORT: PACT stands by a man as he works through the transition from prison to society.
- HOUSING: PACT provides a temporary home for ex-offenders and assistance in finding a permanent residence.
- AWARENESS: PACT exists to make people see that convicts are people like yourself. People who need lots of tough-minded help in regaining the rights and privileges they blew.

PACT IS . . .

a group of community residents from the Northwest Indiana erea, ex-offenders from the Indiana State Prison (ISP), and prisoners of ISP. We are governed by a board of Directors that meets monthly inside the prison and assisted by an advisory council which meets in the outside community.

We believe that what is needed is solid "bridge building" between prisons and the community that will stimulate interaction between offenders and society at large and will enable ex-offenders to participate in work, training, and other aspects of community life. We feel that emphasis in correctional reform should be in providing meaningful community based non-institutional alternatives to incarceration. We believe this is a better investment of tax payers money; a more rational and humane approach to criminal justice; and a positive step toward reducing the presently high recidivism rate (criminal repeaters).
