**1. Updating U.S. Immigration Law**

**Question:** Immigrant communities have seen increased targeting under the Trump administration through the ending of DACA and various Temporary Protected Status (TPS) programs and increased surveillance of immigrant neighborhoods, detention and deportation. The majority of Iowans support a path to citizenship. Will you support immigration reform that provides a road to citizenship, protects workers and keeps families together?

**2. Protecting DACA and TPS beneficiaries**

**Question:** The Trump Administration has created a crisis of uncertainty for recipients of DACA and TPS by arbitrarily canceling the programs. Iowa values and needs these members of our communities. Will you support legislation that provides permanent protections for DACA and TPS recipients?

**3. Defund ICE**

**Question:** Immigration and Customs Enforcement (ICE) is a relatively new federal agency with an egregious track record of abuse and lack of accountability and oversight. Its bloated budget supports racial profiling, family separation and harsh detention methods. Its enforcement operations have destroyed local economies in Iowa. Will you support defunding ICE?

**4. Defund ICE**

**Question:** Since the creation of the Department of Homeland Security in 2003, the amount the US spends on immigration enforcement has more than doubled to almost \$20 billion per year. This spending funds racial profiling, an inhumane detention system, and family separation while failing to keep us safe. It could instead be spent on things that actually benefit our communities like education and jobs. Will you vote to defund ICE and Border Patrol?
